1. Kayin Holdings Sdn Bhd ("KHSB") holds 68.23% shares in SPB.
2. Kayin (M) Sdn Bhd is the registered shareholder of the entire issued share capital of KHSB.
3. Shanti (Kayin) Limited, Amita (Kayin) Limited, Manisha (Kayin) Limited and Lavani (Kayin) Limited are the registered shareholders of the entire issued share capital of Kayin (M) Sdn Bhd.
4. HSBC International Trustee Limited ("HKIT") is the registered holder of the entire issued share capital of Shanti (Kayin) Limited, Amita (Kayin) Limited, Manisha (Kayin) Limited and Lavani (Kayin) Limited under three (3) discretionary trusts of which HKIT acts as trustee.
5. HSBC International Trustee (Holdings) Pte. Ltd. ("HSIT") owns the entire issued share capital of HKIT.
6. The Hongkong and Shanghai Banking Corporation Limited ("HBAP") owns the entire issued share capital of HSIT.
7. HSBC Asia Holdings Limited ("HAHO") owns the entire issued share capital of HBAP.

8. HGHQ owns the entire issued capital of HAHO.

The total 234,447,236 Ordinary Shares are held as follows:

- (i) 194,447,236 Ordinary Shares are registered in the name of Kayin Holdings Sdn Berhad; and
- (ii) 40,000,000 Ordinary Shares are registered in the name of HSBC Nominees (Tempatan) Sdn Bhd - Pledged Securities Account for Kayin Holdings Sdn Berhad.
